

## Vice President, Underwriting and Portfolio Management

- Portfolio management a) analysis evaluating the advantages and disadvantages of alternative investment options and b) assist the Portfolio Manager on investment decisions on behalf of the funds managed.
- Assist in the business planning process generally, as well as specifically, in respect to the lines of business personally written.
- Contribute to investment strategy to maximize expected return of portfolios and the continuous monitoring of portfolio performance versus agreed targets.
- Monitor aggregate exposures by line of business and geography to meet the needs of the risk management framework, and assist with communication with investors
   Execute aggreed business development and marketing
- Execute agreed business development and marketing strategies, developed with executive management, working both individually and within a team. This may require overseas travel.
- Maintain awareness of changing insurance/reinsurance/retro market conditions to take advantage of new opportunities.
- Ensure that the administration of the document management and workflow systems (including the review and execution of slips, contract certainty checklists, population of pricing other risk management information, the maintenance of files and records, underwriter and peer reviews) is carried out in accordance with internal procedures.
- Liaise with Validus Services underwriters to communicate and coordinate AlphaCat risk origination, appetite, and risk/return targets relating to individual deals or at overall fund level
- Proactively contribute to overall systems, investment process enhancements, reporting and communications needs with investor relations
- Other projects as assigned.
