The VP, Global Technical Accounting & Policy reports to the EVP, Chief Accounting Officer and Director of Finance Operations.

- Leadership Proven success in leading high-performing teams, achieving results through others, and being a strong team player.
- Lead the IFRS 17 Insurance Contracts implementation project and ongoing maintenance, assisting with determination of accounting policy elections, formulation of requirements for system configuration, ongoing generation and validation of IFRS 17 results and reporting across the Sompo International group.
- Highly energetic, motivated, and capable accountant to provide expertise in relation to IFRS accounting guidance and emerging issues.
