### **About the role**

In this function, you will be responsible for ensuring the effective delivery of the vision and the strategy for Reinsurance Underwriting within the Property Department. The Underwriter will be focused on the successful management of specific client portfolios and relevant market activity within the MS Amlin AG entity.

Within this role your core responsibilities and duties include:

- Quote, underwrite, manage and attract business on a client relationship basis for specific portfolio and product groups and platforms.
- Alignment to and delivery of tactical client intimacy initiatives within the portfolio(s), markets and product forum.
- Ensure risks are written within the agreed parameters – making sound long term decisions on risks that are written, with a focus on smart rationale underwriting.
- Peer review a broad cross section of risks, quotes and endorsements within an assigned portfolio.
- Ensure the underwriting exposure and RDS reports are maintained and assist in their management and completion on a quarterly basis.
- Maintain up-to-date knowledge of AIR, RMS and similar catastrophe models.
- Assist in analysing quarterly figures and producing projections to identify reserving levels required.
- Liaise with and ensure compliance with underwriting management, taking corrective action as necessary and operating within agreed authorities
- Provide relative reports on the region / product as required.
- Conduct role in accordance with the Company's Business Ethics policy and all regulated entities as appropriate.
- Comply with relevant risk, regulatory and legal requirements and with Group policies as directed by the Lead Underwriter and/or Senior Underwriter.

As Underwriter, you will report to the Head of Property, Bermuda.

- Minimum of 5 years underwriting or broking experience.
- Possession of an industry related certification is required, preferably CPCU, Are or ACII.
- Good knowledge and proven experience of handling new and renewal business within the Property line of business.
- Hands on portfolio control experience within the Property line of business.
- Able to demonstrate achievement of client centric value propositions.
- Existing good working relationships with both clients and brokers; strong relationships with brokers and other distribution channels and an overall orientation towards providing exemplary client service are critical.
- Proven capability of developing new and existing broker and client relationships and run client meetings regularly without support.
- Competent in pricing risks within the area of authority.
- Good understanding of all relevant contract terms and conditions.
- Ability to work and effectively manage matrix relationships.
