- Preparation of the monthly and quarterly management accounts and financial supplements for the Bermuda reinsurance company under UK GAAP.
- Preparation of quarterly reporting packs for executive management and the group board.
- Preparation and review of investor reporting information and management information relating to the Bermuda reinsurance company.
- Participate in the assessment and reporting of capital and solvency returns and the calculation and monitoring of the capital position.
- Preparation of cash flow projections for the Bermuda reinsurance company.

### **Minimum qualifications, skills and experience:**

- Professional accounting qualification (ACA, ACCA, CPA, CIMA or equivalent).
- Experience of accounting for reinsurance contracts under UK GAAP.
- Minimum of 2 years post qualification experience gained in an insurance/reinsurance environment or auditing insurance/reinsurance companies.
