- Present and manage the preparation of financial statements, financial reports, special analyses and information reports to the Board in a timely and transparent manner describing the true nature of BHB's financial position
- Establish systems of good financial governance to ensure an effective process for decision making and identification of any operational or financial risks.
- Develop a short, medium and long term financial strategy to ensure that BHB is able to meet its strategic aims and objectives and provide its mandated clinical services within the available resource envelope
- Develop and oversee operating and capital budgets, along with long-term budgetary planning and cost management for all BHB Directorates and ensure that budget holders operate within agreed budgets and strategic plan
- Regularly, develop and monitor financial and operational performance indicators to enable directorates to manage and improve performance.
