Applicants must demonstrate that they are trained in teaching at the specific school level for which they are applying. All applicants will also be asked to teach a lesson which reflects standards of exemplary teaching or to submit a videotape of a recent lesson which has been taught by the applicant. In addition to the above, a copy of a recently signed performance appraisal from their immediate supervisor is required.
