The independent Office of the Privacy Commissioner is

established by the Personal Information and Protection Act 2016 (PIPA). The Privacy Commissioner is tasked with ensuring compliance with the provisions of PIPA, and that the purposes of the Act are achieved. PIPA seeks to ensure the protection of personal information, and to regulate its use in Bermuda. The Act also plays an important role in the development of Bermuda's cybersecurity framework, and of a successful digital economy.

The Privacy Commissioner will be responsible inter alia for:

Undertaking reviews and investigations
Providing reports on implementation of the provisions of

the Act

the privacy issues that can arise from their use.

- Developing public awareness and guidance in relation to the rights of individuals
- Developing public awareness and guidance in relation to the obligations of organisations
- the obligations of organisations

For this critically important role, we need an outstanding individual, with a comprehensive knowledge of data protection, privacy law and its operation. The successful candidate must also have a strong understanding of information and communication technologies, data processing methods and

The successful candidate will need:

A minimum of ten years of relevant experience in privacy/ data protection or a related field, including five years in a senior level management position.

Candidates should hold a Bachelor's degree in Law, Public Administration, Management, Political Science or relevant subject matter along with a practical qualification in data protection and privacy such as the Practitioner Certificate in Protection or a similar qualification.

As well as these technical skills, candidates must demonstrate the ability to command the respect of local and international stakeholders, maintain appropriate networks and establish

effective relationships. Candidates must hold an appreciation for the complexities and sensitivities associated with filling this role in a small jurisdiction.
