The Mental Health Case Manager will be an integral member of CAS' multi-disciplinary team (MDT) with responsibility for providing first line triage for service requests, carrying out treatment for youth and families as well as maintaining and managing a case load of clients.

#### Key responsibilities include:

- Conducting intake and triage assessments including risk assessments
- Identifying, initiating and coordinating therapeutic interventions consistent with scope of practice and level of competence
- Providing clinical support for in-patient, day, and community services as required
- Consulting with the multidisciplinary team and other care providers to discuss changes related to the status of patients and modify interventions
- Providing counselling, therapeutic interventions and treatment that assists the patient in developing, improving, or regaining skills, social and community supports
- Documenting complete accurate and relevant data for every patient, according to the policies of the Bermuda Hospitals Board
- Advocating for and supporting the principles of the recovery model and patient and family-centred care Supporting the development of students and colleagues through preceptorship and providing ongoing mentorship

#### Qualifications &/ registration required:

- Masters' degree in Psychology, Social Work, Nursing, Counselling or related field – with concentration in Child and Adolescent Mental Health or Family Therapy/Counselling
- Specialist certification in Child Adolescent and Family Mental Health from an accredited institution preferred
- A minimum of three (3) years' experience providing intervention with children in either education or a mental health facility
- Must be trained in verbal intervention techniques
- Current registration with discipline specific body in Bermuda or overseas
- Valid Bermuda Government Driver's License
- Familiarity with behavioural modification concepts and techniques
