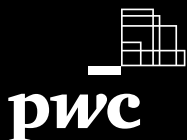

Finance Manager - TD Financial International Ltd (TDFIL) and TD Bermuda Limited

(TDBMU) are Bermuda – based operating subsidiaries of TD Bank. The business strategies of the two Bermuda entities are similar, set up to participate in group financing structures and other inter – company transactions. The core activity is the granting of loans to TD Bank Group companies.

Reporting to the President and Director, TDFIL and TDBMU, the Finance Manager will perform a broad series of functions including: accounting, financial statement preparation and analysis, control, risk management and corporate governance, in support of company activities and aligned with TD Bank Group policies and practices.

Core responsibilities in the role include the following:

- Report on a regular basis to the Board of Directors, the shareholders, appropriate local authorities and other stakeholders as required on the financial, governance and compliance affairs of TDBMU and TDFIL;
- Analyze fixed income investments to ensure accuracy of intercompany loans;
- Preparation of management accounts, financial statements, and regulatory reports as required, ensuring timeliness and accuracy. Preparation of all accounting functions required to maintain the companies' books and records in accordance with appropriate accounting and compliance standards;
- Develop and maintain Policies/Guidelines in order for the company to have excellent governance, bringing/ policies to the Board for approval;
- Maintenance of Compliance Reports and Procedures Manual;
- Ensure that a strong culture of risk, compliance and policy awareness is evident within TDBMU and TDFIL, and ensure that a system is in place to deliver metrics tracking all important business indicators and deliverables. Comply with applicable professional standards and demonstrate governance, control and risk management behaviors in alignment with TD policies and practices; and
- Partner closely with the President of TD Financial International Ltd. to provide support and back up as appropriate.

Required candidate profile

The role requires a qualified accountant with relevant professional experience gained within the financial services or assurance sectors, capable of multi-tasking effectively, as well as possessing the ability to interact with multiple internal stakeholders across the Group;

- Qualified accountant with at least 5-8 years' post qualification experience gained within the financial services sector;
- Demonstrable, practical experience in financial statement preparation and management accounting;
- Experience analyzing and reporting upon fixed income investments, as well as dealing with inter-company financing and related treasury activity; and
- Current or recent experience in compliance and risk monitoring and reporting, would be strongly preferred, being important components of the role.

Key personal qualities will include:

- Excellent inter-personal skills conducive to working in a small office environment;
- Advance Microsoft excel skills;
- Ability to work under pressure, particularly at month and quarter – end; and
- Willingness and aptitude to perform a multiplicity of tasks and to assimilate the TD Bank Group operating culture.
