## Registered Nurse - Home Dialysis

## **Essential Duties and Responsibilities:**

- Develop, maintain, coordinate, provide, and manage nursing care services and plans for the Home Peritoneal, Home Hemodialysis patient and CKD patients. Advocate for a group of assigned patients
  - Identify patient needs; coordinate care plan decisions with physicians and health care team and in compliance with orders and protocols; provide patients, families, physicians, and health care team with information related to care plan decisions and needs; provide emergency care as needed
