# Re: Internal Review Decision regarding the PATI Request to the Ministry of Economic Development and Tourism

Thank you for your PATI request submitted to the Ministry of Economic Development and Tourism. I acknowledge your request for an internal review submitted to our offices on May 23, 2018. I regret that I was unable to comply with the requirement that a decision was due to you by July4, 2018. However, I am now able to provide you with such a review.

I write to inform you that we are able to provide you with email correspondence regarding a trip made to Miami, Florida in May 2015. This correspondence is attached.

However, I write to inform you that the requested records regarding the Bermuda Government's relationship with the company MM&I Holdings are not subject to disclosure on one or more of the following grounds:

- 1. Any correspondence generated by and from the office of the Attorney General is exempt from the application of the PATI Act ("the Act" by operation of s. 4(1)(b)9vi);
- 2. Any correspondence referencing deliberations of the Cabinet or material before Cabinet is exempt under s. 27(1);
- 3. Any correspondence relating to Government communications with a third party which gave information to Government on the understanding that it would be treated as confidential is exempt pursuant to s. 26 of the Act;
